£500 One-off Payment for Working Households Receiving Tax Credits

A £500 one-off payment for working households receiving tax credits was announced as part of the UK Government Budget.

Further guidance has now been released which confirms that the new payment is being introduced to provide extra support when the temporary increase in working tax credits - that was introduced in April 2020 in response to the Covid-19 pandemic - ends as planned on 5 April 2021, the new guidance advises that -

- applications for the new payment are not required as HMRC will contact claimants by text message or letter in April 2021 to confirm eligibility;
- eligible claimants will include those who, on 2 March 2021, receive working tax credit payments; both working tax credit and child tax credit payments; or child tax credit payments where they are eligible for working tax credit but do not get a payment because their income is too high; and
- the £500 payment should be paid to eligible claimants by 23 April 2021.

- Grants between £1-2000 (up to a maximum of £5,000)
- Who can apply? Community groups, membership groups, voluntary groups, social enterprises, and charities
- Purpose to provide small grants to community and voluntary groups across Scotland who are connecting and supporting people within their local community.

- Grants ranging from £300 £200,000 depending upon the fund

- Purpose supporting community related projects, improving community spaces and on the wellbeing of those most in need. There remains a focus on covid related work and supporting those most vulnerable.

- Community Building Grants
 - o Grants up to £75,000
 - Who can apply? registered charities with an annual income of over £25,000
 - Purpose capital grant fund for funding towards new buildings or the upgrade of existing buildings for community hubs
- Large Grants, Small Grants, Wee Grants Programmes
 - Wee Grants up to £2,000, Small Grants £2,500-£15,000, Large Grants £15-50,000
 - Who can apply? criteria for applying varies per fund and depends upon the size of the organisation and their annual income if they are a charity. Wee Grants can be applied for by constituted community groups
