Community Renewal Fund

In response to the UK Government's recent announcement on the UK Community Renewal Fund, Highland Council are seeking bids from organisations wishing to deliver activity as part of this. Eligible applicants can come from public sector organisations, higher and further education institutions, private sector companies and registered charities. It is predominantly a revenue based fund and bids will be for 2021/22 only with activity ending by 31 March 2022.

Project delivery must align with at least one of the investment priorities contained within the UK Community Renewal Fund Prospectus namely:

- Investment in skills
- Investment for local business
- Investment in communities and place
- Supporting people into employment

Community Support Co-ordinators

A reminder that the closing dates for these posts is Monday 10 May. There are 10 posts located across Highland: Inverness, Nairn, Aviemore, Lochaber, Skye, Sutherland, Caithness, Ross-shire East, West and Mid (3 posts). They are fixed term posts for 12 months.

The main purpose of the role is to co-ordinate and deliver humanitarian and resilience support, building community capacity and resilience through active engagement with a range of bodies including community and public sector organisations. There will be a focus on developing local relationships and networks with community bodies, encouraging participation and involvement, with an emphasis on addressing poverty and recovery.

The posts will be part of the Community Support and Ward Management team and although based in one area, will work as part of the wider area-based team to support projects and activity across the broader area.

Community Food Growing Co-ordinator

We are also recruiting to the post of Community Food Growing Co-ordinator. This is a 24 month post and the post-holder will lead on the delivery of the Council's approach to supporting food growing initiatives across Highland, as required under the Community Empowerment (Scotland) Act 2015. In doing so, the post-holder will help to reduce food poverty across Highland, improve community resilience whilst also building community capacity through active engagement with a range of bodies including community and public sector organisations.

A key initial focus will be finalising the Council's draft food growing strategy, <u>Growing Our Future</u>, whilst taking forward the key actions identified within the strategy. The post-holder will be expected to support community engagement activity related to the food growing agenda as well as the Council's 'Placed Based approach', including developing local relationships and networks with community bodies, encouraging participation and involvement, with an emphasis on improving food growing outcomes and healthy lives across the region.
